The recent Supreme Court decision in *U.S. v. Arthrex, Inc.* provided the Director of the United States Patent and Trademark Office (USPTO) the authority to review a Patent Trial and Appeal Board (PTAB) final decision in an inter partes review by rehearing. The USPTO has implemented an <u>interim procedure for Director</u> <u>review (https://www.uspto.gov/patents/patent-trial-and-appeal-board/procedures/usptoimplementation-interim-director-review</u>) consistent with this decision.
